1. The Tanzania Bureau of Standards Tender Board invites sealed bids from reputable service providers to bid for the above advertised tender.
2. Tendering will be conducted through the International Competitive Tendering procedures specified in the Public Procurement Act. No. 21 of 2004, the Public Procurement (goods, works, non-consultant Services and disposal of public assets by tender) Regulations 2005.
3. A complete set of bidding document(s) and additional sets may be purchased by any interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of USD 300.00 (United States Dollars Three Hundred Only). This sum covers tender administration costs. Payment should either be by Banker's Draft, Cash or Banker's Cheque, to the **Director, Tanzania Bureau of Standards, P O Box 9524, Dar es Salaam.**
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the office of the Secretary, Tanzania Bureau of Standards Tender Board, P O Box 9524, Dar es Salaam, Tanzania, Ubungo Area, Morogoro/Sam Nujoma Roads from 8.00 am to 15.00 pm on Mondays to Fridays inclusive except on public holidays.
5. All bids in one original plus four copies, properly filled in and enclosed in plain envelopes shall be addressed to the Secretary, Tanzania Bureau of Standards Tender Board, P.O. Box 9524, Dar es Salaam, Tanzania and must be accompanied by an original Bid Security in the form of Banker's Draft or Banker's Cheque in the amount of **USD 50,000:00** (United States Dollars Fifty Thousand Only) properly addressed to the Director, Tanzania Bureau of Standards. Bids may either be delivered by hand or be sent by registered post or sent by courier so as to

reach the Secretary, Tanzania Bureau of Standards Tender Board, Morogoro/Sam Nujoma Roads, P.O. Box 9524, Dar es Salaam, Tanzania before the deadline for submission of bids.

6. Tenderers may quote for one lot or both, but in any case a bidder must quote for all countries in the respective lot. Partial bids will not be accepted.
7. The deadline for the submission of bids is **10h00 local time on Tuesday, 25<sup>th</sup> November 2008**. Bids will be opened in public and in the presence of bidder's representatives who choose to attend at the Tanzania Bureau of Standards Conference Room, Morogoro/Sam Nujoma Roads, Ubungo Area, Dar es Salaam, Tanzania at **10h00 local time on Tuesday, 25<sup>th</sup> November 2008**. Bids sent by post must be registered. The outer cover shall be clearly marked "**TENDER NO. 02 TBS OF 2008/2009 FOR PROVISION OF PRE-SHIPMENT VERIFICATION OF CONFORMITY TO STANDARDS (PVoC) SERVICES FOR TANZANIA BUREAU OF STANDARDS**".
8. Telegraphic, telefax and late non-telegraphic and telefax bids will not be accepted. Bids not received and not opened in public at the public bid opening exercise shall not be accepted for evaluation irrespective of the circumstances.
